

CHAOS COURT

A DEBATE & ACCUSATION MODE

SETUP

Deal each player a Character Card, the matching Reveal Card, and an Energy Marker.

Choose the courtroom roles:

- **Supreme Bitch:** Judge
- **Defendant:** Player to the Judge's left
- **Prosecutor:** Player to the Defendant's left
- **Defense Attorney:** Player to the Defendant's right
- **Everyone Else:** Jury

The Judge announces the Defendant's ridiculous crime.

THE TRIAL

Everyone stays in character using their Character Card, Reveal Card, and Energy Marker.

The Charge

The Judge announces the crime.

The Prosecution — 30 Seconds

The Prosecutor explains why the Defendant is guilty.

The Defense — 30 Seconds

The Defense Attorney explains why the Defendant is innocent.

The Witness — 15 Seconds

The Judge chooses one Jury member to give surprise testimony.

The Final Plea — 15 Seconds

The Defendant makes one final argument.

THE VERDICT

The Jury votes simultaneously:

Guilty: The Defendant and Defense Attorney drink.

Not Guilty: The Prosecutor drinks.

Tie: The Judge makes the final ruling.

OBJECTION!

Once during the trial, any player may yell:

"OBJECTION!"

The Judge immediately rules:

Sustained: The person speaking must change their argument.

Overruled: The person who objected drinks.

COURT ADJOURNED

One trial completes the game.

Want another case? Rotate the roles and start again.

DIRTY LITTLE DOCKET

Every character has a record. Choose a charge—or prosecute the Defendant for something even messier.

BAR CRIMES

- Unlawful relocation of an unattended cocktail
- Financially supporting everyone's bad decisions
- Hijacking karaoke without a performance permit
- Turning a load-bearing pole into a performance venue

CRIMES OF SEDUCTION

- Unauthorized booty acquisition
- Recruiting a Daddy under suspicious circumstances
- Unauthorized use of penis telepathy
- Unlawful occupation of another person's thigh

CRIMES AGAINST THE VIBE

- Distribution of glitter at an active crime scene
- Assault with a deadly hair flip

- Impersonating an emotionally stable person
